- 5 PartsLookup will automatically update any required files, and may reboot your system.
- 6 Continue with PartsLookup Installation following all instructions
- 7 Price files can be updated at this time.

Install New/Updated Vendor Price Files ONLY:

- 1 Insert the CD into the CD Drive
- 2 When the first screen appears click on the EXIT button.
- 3 With PartsLookup running, click on the UTIL button(F12)
- 4 Click on Add/Delete Price Files button
- 5 You may add, delete, or update only newer price files, as required
